SUBDIVISION ROAD REPAVING PALMER WOODS ESTATES SUBDIVISION SECTION 11 SPECIAL ASSESSMENT DISTRICT NO. 414

TO THE OWNERS OF THE FOLLOWING DESCRIBED PROPERTIES:

T2N, R10E, SECTION 11, PALMER WOODS ESTATES SUBDIVISION, LOT 1 THRU LOT 10, INCLUSIVELY.

All in Bloomfield Township, Oakland County, Michigan.

PLEASE TAKE NOTICE THAT the Township Board of the Charter Township of Bloomfield has tentatively declared its intention to make the following improvements:

The paving and associated construction items of Wellsley Court within the Palmer Woods Estates Subdivision.

The project consists of removing the existing road and placing hot-mix asphalt (HMA) overlay pavement four (4) inches thick at full width between the existing concrete curbs. A limited amount of the existing concrete curbs may be replaced or repaired and minor drainage improvements will be made to reasonably assure drainage of the pavement. All disturbed areas will be covered with topsoil and sod. A maximum five (5) foot approach will be constructed to existing driveways to provide a smooth transition from the newly paved roadway.

In addition, the Township Board has designated the special assessment district against which the cost of said improvements is to be assessed as consisting of all lots and parcels of land as set forth above. purpose of hearing any objections to the improvements and to confirm the special assessment roll.


